It will highlight the amended loss mitigation procedures for borrowers affected by the disaster — as referenced in ML 2018-01 and Section III.A.3.c.iv. of FHA *Single Family Housing Policy Handbook* 4000.1 — with FHA-insured mortgages whose property and/or place of employment is in the Presidentially-Declared Major Disaster Areas (PDMDAs) of Puerto Rico Hurricane Maria (DR-4339) or U.S. Virgin Islands Hurricane Maria (DR-4340), and who have not previously received an FHA permanent Loss Mitigation option relative to the referenced PDMDAs.
